## **KEY RESPONSIBILITIES**

#### Program Management

- Manage various projects that advance LCF's mission and economic justice goals. When needed, liaise with team members to support with implementation of projects.
- Monitor and engage in policy and economic development efforts in Fresno and Salinas. Collaborate with the LCF policy team to develop strategies and opportunities to advocate at a regional and state level.
- Research key data, policy, models, and best practices that can inform LCF initiatives and programs.
- Lead program learning and evaluation. Compile and analyze annual data from LCF grantee reports and program events.
- Write blogs and produce written content to elevate a Latino-driven narrative of California's economy, local-based work, and Latino entrepreneurship.

### Funding and Grants

- Support team in identifying, vetting, and tracking Latino nonprofit organizations eligible for LCF funding. Review grant proposals and provide verbal and written recommendations of organizations to fund.
- Work closely with grantmaking team to support with due diligence, grant processing, and execution of grant agreements. Support with data input and upkeep of Salesforce records.
- Support development team with fundraising efforts, including writing grant proposals and reports.

#### External Engagement

- Develop authentic relationships with key community partners to facilitate cross-sector collaboration.
- Communicate effectively with key partners and stakeholders by email, phone, and in person. Provide timely follow ups to conversations or meetings with partners.
- Facilitate internal and external meetings. Be comfortable with public speaking and open to participating in interviews with media.
- Co-lead event planning related to virtual and in-person convenings, trainings, and community engagement opportunities.
- Plan and participate in site visits with partners. Be willing to travel across the Central Valley, Central Coast, and Bay Area to meet with partners, LCF staff, and funders.
